For the 2022 tax season, GECC volunteers prepared 8,013 federal tax returns and 7,573 state tax returns resulting in more than \$10 million in federal and state refunds. This saved GECC's clients over \$2 million in tax preparation fees. This was accomplished by in-kind donations of 12,563 volunteer hours valued at \$262,441.
