### WHAT IS GATEWAY EITC COMMUNITY COALITION?

We are a non-profit organization dedicated to preparing tax returns free of charge for individuals and families earning less than \$54,000. Our partners include AARP Foundation, Internal Revenue Service, St. Louis County CORP, United Way of Greater St. Louis, and University of Missouri St. Louis. Since 2003, we have filed more than 87,000 federal tax returns, bringing back \$98 million in refunds to our community.

### FREE SERVICES OFFERED

Come to one of our FREE Tax preparation sites, and our IRS-trained and certified preparers will complete your tax return and e-file it for free. Receive your refund in 7-10 days when you take advantage of direct deposit, for free. You may also qualify to receive up to \$6,431 when you claim the Earned Income Tax Credit (EITC). See our site listing inside this brochure and for more free tax preparation sites in the St. Louis region, simply dial 2-1-1.

### OTHER FREE SERVICES OFFERED\*

Take advantage of these additional financial services at our tax sites:

## WHY SHOULD YOU PAY TO GET YOUR OWN MONEY BACK?

### WHAT YOU NEED TO BRING:

- All W-2s and Forms 1099
- Social Security Cards or Individual Taxpayer Identification Numbers (ITIN) for all family members
- Valid picture ID for taxpayer and spouse (Driver's License, State ID, Passport)
- Copy of 2017 tax return
- Form 1098 or real estate tax receipt
- Proof of unemployment compensation
- A copy of a voided check or bank account with routing numbers for direct deposit
- Proof of child care expenses
- Parcel number (Illinois homeowners only)
- Form 1095 - Proof of health insurance

Note: If married and filing jointly, both spouses must be present to sign.

### WE PREPARE:

- Form 1040
- With schedule B, C (\$25,000 limit) and EIC
- Form 2441 (Child and Dependent Care Credit)
- Form 8863 (Education Credits)
- Form 8812 (Additional Child Tax Credit)
